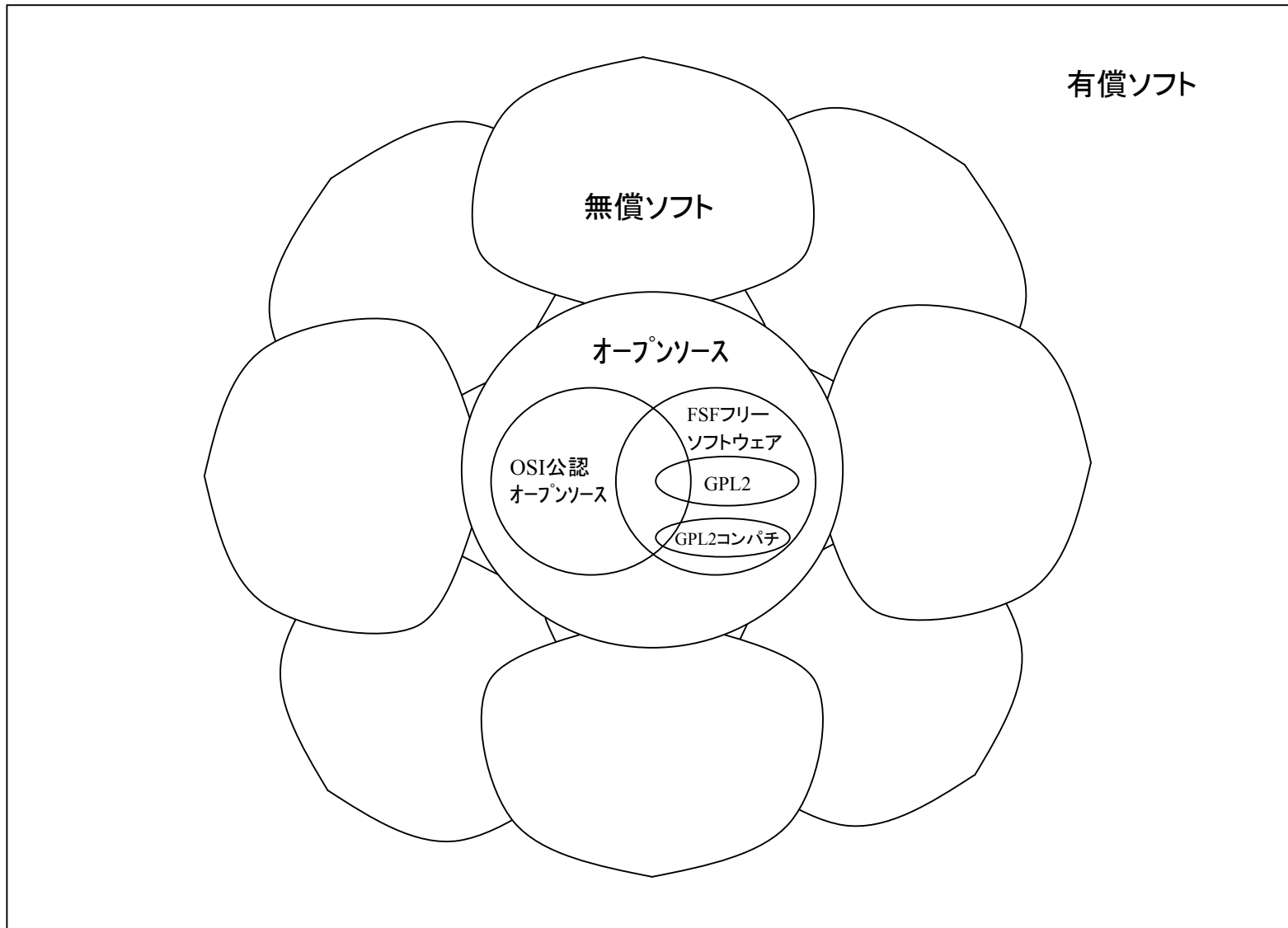
Copyleft

- 「ソフトウェアを再配布するには、再配布を受けた者にも、複製と変更の自由を与えなければならない」
- 本来は独占的権利であった著作権を、複製・変更・再配布の自由を拡散するために利用
- "right" を逆手にとったという意味で "left"

OSI vs FSF



フリーソフトウェアの定義 (FSF)

0. 目的のいかんを問わず、プログラムを実行する自由
 1. プログラムの動作を研究し、必要に応じてプログラムを改変する自由
 2. 再配布の自由
 3. プログラムを改良し、改良部分を公表する自由
- ソースコードへのアクセスは第2・第4の自由の前提となる。
 - 無料であっても、フリーソフトウェアとは限らない。

Open Source Initiative (OSI)

- 22 Jan 1998: ネットスケープ, コード公開を発表
- 3 Feb 1998: パロ・アルトでのブレイン・ストーミングで "open source" の用語が固まる
- Early February: "open source" 対 "free software" の議論が盛り上がる
opensource.org のサイト立ち上げ
- 23 Feb 1998: ネットスケープ, オライリーが"open source"に言及
- 31 Mar 1998: Navigator ソースコードのリリース
- 7 Apr 1998: "Freeware Summit Conference" で "open source" の用語と営利目的を採択
- April 1998: "open source"の用語が業界報道に浸透
- 22 November 1998: OSI をカリフォルニア州公益法人とすることを発表
- Apache/Linux プロジェクトの成功と某M社への脅威(H文書)

OSI によるオープンソースの定義

1. 再頒布の自由
2. ソースコード
3. 派生ソフトウェアの作成・頒布
4. 原作者のソースコードの完全性
5. 個人または集団の差別禁止
6. 利用分野の差別禁止
7. 原ライセンスの汎布
8. 特定製品でのみ有効なライセンス禁止
9. 他のソフトウェアの同梱制限ライセンス禁止

Mozilla vs GPL

- Mozilla はオープンソースのフリーソフトウェアであるが、GPL と両立しない。
- 複雑な制約条件
- 特許に関する条項
- 複数ライセンス可能(GPL とのデュアル・ライセンスは可能)

OSI vs FSF

● OSI公認オープンソースであるがFSF公認フリーソフトでないもの。

APSL 1.2: 組織内で配布された改変は公表しなくてはならない。

GPL両立性の阻害要件①

- ライセンサーによる一方的ライセンス終了条項
(⇒ 消費者契約法)
- 改変部分の公表・グラントバック強制
(⇒ 独禁法)
- 変更されたバージョンの配布制限
- ライセンス・フィーの徴収

⇒ FSF nonfree ⇒ GPLと矛盾

GPL両立性の阻害要件②

- ユーザーの自由を不当に制約する条項
- ユーザーにGPLにはない要求を課する条項
- BSD宣伝条項【BSD, Apache, Zope】
- 配布の概念を不当に広げる条項【LaTeX】
- 変更したソースをパッチでしか配布できないとする条項【Qt】 (⇔ OSD)

GPLの加法規則

- $\alpha + \beta = \gamma$
- $\alpha = \text{GPL}$ 、 $\beta = \text{GPL}$ 両立のとき $\gamma = \text{GPL}$
- $\alpha \doteq 0$ のときは？
- $\alpha \ll \beta$ のときは？
- “Merge”の著作権法上の効果

GPLの減法規則もしくは魔女算術

- $\gamma = \text{GPL}$ のとき $(\gamma - \alpha) = \text{GPL}$
- $\alpha + \beta = \gamma$

$$\text{GPL}(\alpha) + \text{BSD}(\beta) = \text{GPL}(\gamma)$$

$$\text{BSD}(\beta) = \text{GPL}(\gamma) - \text{GPL}(\alpha) = \text{GPL}(\gamma - \alpha)$$

$$\therefore \text{BSD}(\beta) = \text{GPL}(\beta) \quad \square$$
